

## **TERMS & CONDITIONS OF INDIVIDUAL MEMBERSHIP IN THE WORLD CAPOEIRA FEDERATION**

### **1. GENERAL PROVISIONS**

Irrespective of nationality, capoeira group, gender or age any individual can request the World Capoeira Federation (hereafter referred to as WCF) individual membership. Individual members do not have the right to vote at conferences and cannot nominate their candidacy in elections. Minors must have the consent of the guardian/parent along with the application for membership.

The decision on the admission of individual member is adopted by the President of WCF or a person authorized by the President.

While applying for individual membership a person agrees to pay the annual fees, as may be amended from time to time in accordance with the bylaws.

### **2. MEMBERSHIP**

Individual membership will be activated within 30 (thirty) days after we receive from you a completed application form and payment. Individual membership is for 2 (two) year commencing on the date your membership is activated.

Individual membership will be extended automatically for successive 12 (twelve) month terms unless you send us written notice you do not want it renewed at least 30 (thirty) days before the end of the membership.

A notification will be sent to you before your membership renewal date which is payable prior to your renewal date for membership fees paid annually.

### **3. OBLIGATIONS OF INDIVIDUAL MEMBERS**

The obligations of the individual member are:

- a. to follow the Statute, rules and regulations of the WCF, to refer them in the activity;
- b. regularly participate in WCF's events;
- c. regularly pay membership fee;
- d. to assist realization of aims of the WCF;
- e. to implement the decisions of the authorities of the WCF.

### **4. MEMBERSHIP FEE AND PAYMENTS**

By accepting these Terms and Conditions you agree to pay 30 Euro at once. This amount will include the price of WCF international Capoeira passport, the cost of shipping of the passport to your home address and 2 (two) years individual membership fee. After the completion of period of 2 (two) years, your annual membership fee will be 5 (five) Euro per year. A receipt will be issued upon receipt of payment for a full subscription.

All sums properly invoiced to the individual member must be paid due to the date. If any such sum is outstanding then from such time the individual membership shall be suspended.

There is no refund of any membership fees nor the passport, should you cancel your membership at any stage during your membership year.

The WCF reserves the right to alter the individual membership fees from time to time. Changes to membership fees will only be made at the time of annual renewal of your membership.

### **5. RIGHTS OF INDIVIDUAL MEMBER**

An individual member has the following rights:

- a. to bear an official ID document of the WCF;
- b. to send complain to corresponding bodies of the WCF regarding admittance to membership and discharge from the WCF (this item also applies to candidate members)
- c. to appeal to WCF's Management Board for supporting their own interests;
- d. to object and to complain about corresponding member and body of the WCF;

- e. to be informed about the WCF's activity;
- f. to participate in discussions related to their own rights and duties.

#### 6. TERMINATION OF INDIVIDUAL MEMBERSHIP

Membership in the WCF is terminated in the following conditions:

- a. voluntary refuse from membership;
- b. getting discharge from membership.

#### 7. DISCHARGE FROM INDIVIDUAL MEMBERSHIP

An individual member of the WCF is discharged from membership in the following conditions:

- a. non-payment of membership fee;
- b. violating the provisions of the statute;
- c. avoidance from assisting to realization of aims and duties of the WCF;
- d. regularly non-participation in events without any excusable reason;
- e. undisciplined actions;
- f. committing mistakes that may damage the name, activity and general interests of the WCF.

#### 8. USING OF NAME AND LOGO OF WCF

As long as you remain a member in good standing, you may use WCF's name and logo, in the format and with the notices provided or requested by WCF.

#### 9. PRIVACY

The information you provide us is "personal information". This information is being collected for the purposes of processing your application, to provide you with membership services, including creation of profile in WCF website, and to keep you informed of upcoming events. The intended recipient of this information will be WCF and its service providers. The provision of this information by you is voluntary. However, if you do not provide the information requested, the WCF may be unable to process your application.

You have the right of access to your profile, and alteration of, personal information concerning yourself as allowed. The information is being collected by the WCF and will be held by the WCF. But as necessary WCF may disclose the information you provided WCF to satisfy any law or regulation.

#### 10. COMPLIANCE WITH LAWS

Anything contained in this Agreement to the contrary notwithstanding, the obligations of WCF and individual member shall be subject to all laws, present and future, of Government of Republic of Estonia having jurisdiction over WCF.

#### 11. FORCE MAJEURE

Neither WCF nor individual member shall be liable hereunder by reason of any failure or delay in the performance of its obligations hereunder on account of strikes, shortages, riots, insurrection, fires, flood, storm, explosions, disaster, war, governmental action, labor conditions, earthquakes or any other cause which is beyond the reasonable control of such party.

#### 12. FINAL PROVISIONS

This application is official document and may be executed in one or more counterparts, each of which shall be deemed an original, but collectively shall constitute one and the same instrument.

Any variations made to these Terms & Conditions may be made by the WCF without express written notice to existing individual members and will be effective 30 (thirty) days after the posting on the WCF's website.
